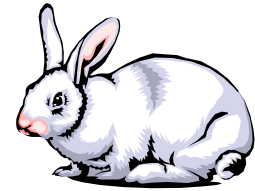




# RICHLAND COUNTY 4-H RABBITS R US RABBIT SHOW

All entries **not entered by April 14, 2020 will be \$3.00 per entry.** There will be trophies for all breeds that are pre-registered. Show includes crossbreeds, purebreds, and meat classes. This year we will have two judges judging the breed classes and one showmanship judge. **Health checks will be performed and rabbits found to be unhealthy will be removed from the show.**

All entries are final and there will be **no** refund of entry fees. Animals are to be brought in their own cages. Exhibitors will be responsible for cleaning up after their own animals. Richland County 4-H Rabbits R Us Club and Show Committee and Richland County 4-H Program are not responsible for any losses due to fire, theft, or accident. Every precaution will be taken to prevent such occurrences.

Please include the tattoo number on the registration sheet. If your rabbit is not tattooed, putting a number in the ear with a black marker will be accepted. If you send the tattoo numbers, the remark cards will be already completed upon registration the day of the event.
